<p>The present complaint was filed on 19.03.2021 and the defence of the respondent was struck off vide order dated 23.08.2023 as the respondent has not submitted reply despite service of notice even through publication.</p> <p>The counsel for the complainant states that this project is an affordable housing project and the complainant has paid hard earned money to the respondent for allotment of a flat with the hope that he would be given possession as per the provisions of Affordable Housing Policy. The due date for handing over of possession was 20.07.2022 (4 years from the date of approval of building plan). However, despite having paid an amount of Rs.8,23,150/- to the respondent against a total sale consideration of Rs.25,32,600/-. It is further stated that the land title of the respondent No.1 is not clear and a civil suit was going on about the land in question at the time of</p>

The proxy counsel for the respondent No.1 has appeared today and states that reply will be submitted very shortly. This contention cannot be accepted as the defence of the respondents has already been struck off. However, in all fairness and in the interest of justice, the respondent may file written arguments within a period of 2 weeks with an advance copy to the complainant.
