Proceedings

The present complaint was filed on **11.04.2022** and registered as **complaint no. 1455 of 2022**. Despite proper service of notice, no written reply has yet been filed. Moreover, the service is also confirmed from the fact that on the last date of hearing, Udayan Yadav and Yash Sharma, A.R's of the respondent company appeared and were directed to file the reply within two weeks, i.e., by 26.07.2022.

Written reply has not been filed by the respondent so far. 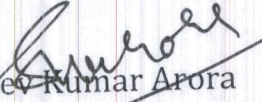

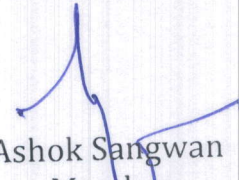
