**Proceedings**

The Hon'ble NCLT vide its orders dated 25.3.2022 in case No.IB-204(ND)2021 case title as Union Bank of India Versus M/s Supertech Limited has declared moratorium in terms of section 14 of the Code and Shri Hitech Goel, was appointed as Interim Resolution Professional.

In Appeal bearing No. Comp. app(AT)(Inst) No.406 of 2022 and IA No4574,4712 of 2022, 634,2763,3330,3331,4316,3619,4306,4973 of 2023 and 2981 of 2024, the Hon'ble NCLAT in the matter of Ram Kishor Arora Suspended Director of Supertech Limited Versus Union of India and Another, vide orders dated 8.7.2024 has clarified that in view of the express order dated 12.9.2022, where following had been directed :-

"The CIRP order has not been stayed. The Moratorium is continuing. Hence no clarification is required.

Applications are disposed off accordingly,.
