Proceedings

The present complaint has been received on 28.01.2022. Reply on behalf of respondent not received yet.

The complaint was adjourned sine die vide order dated 31.03.2022, on account of respondent no.1 being in Corporate Insolvency Resolution Process before NCLT Delhi Bench.

Now, the complainant has moved an application on 06.05.2024, for restoration of complaint stating that the Hon'ble authority in suo-moto complaint No. 5802/2019 has passed certain directions regarding transfer of the assets and liabilities in respect of the project 'Supertech Azalia' to M/s DSC Estate Developers Pvt. Ltd. Thus, the complainant is seeking restoration of the present complaint and is seeking impleadment of M/s DSC Estate Developers Pvt. Ltd. as a party to the present complaint.

On 19.04.2024, the complainant has stated that the related project Supertech Azalia is not in the ownership of Supertech Ltd. which is under NCLT. Thus, the complainant is seeking restoration of present complaint as it was adjourned sine-die, treating the same being covered in the IBC proceedings.
