Proceedings

It has been brought to the notice of the Authority that National Company Law Tribunal, Principal Bench, New Delhi vide order dated 20.08.2019, passed in case bearing C.P.No.IB-1564(PB)2018- titled Rachna Singh & Another versus Umang Realtech Pvt. Ltd. under section 7 of the Insolvency and Bankruptcy Code, 2016 has admitted the application under Section 7(5)(a) of the IBC. Accordingly, the CIRP is initiated and moratorium is declared in terms of Section 14 of the Code. As a necessary consequence of the moratorium in terms on 14 (1) (a) (b), (c) and (d), the following prohibitions are imposed which must be followed by all and sundry:

- (a) *The institution of suits or continuation of pending suits or proceedings against the corporate debtor including execution of any judgment, decree or order in any court of law, tribunal, arbitration panel or other Authority;*
