Proceedings The present complaint was filed on 21.10.2021 and registered as complaint no. 4138 of 2021. On the last date of hearing, Shri Vikas Verma appeared on behalf of respondent appeared wherein a direction was given to file the reply by 17.08.2022 with a cost of Rs. 5,000/- to be paid to the complainant. Despite proper service of notice, no written reply has yet been filed. Case has been called out but no one has appeared on behalf of the complainant. The counsel for the respondent requests for a short adjournment for filing of reply and objections on the ground that the complaint is not maintainable. The counsel for the respondent undertakes to file detailed reply within two weeks i.e. by 21.11.2022 in the registry with a copy to the complainant failing which cost of Rs.10,000/- be paid to the complainant. Last opportunity is being granted. In case the reply is not filed within the time allowed, the defence of the respondent may struck off.

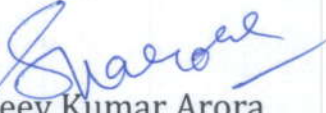

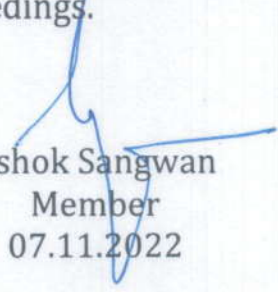
