<p>The present complaint has been filed on 21.10.2022. the reply on behalf of respondent has been filed on 02.05.2023 as well as filed an application under order 1 rule 10 of CPC 1908 for impleadment of M/s Prime IT Solutions Private Limited.</p> <p>On the last date of hearing the counsel for complainants were advised to collect the copy of said application from the registry and has to file the response to the application within period of 15 days. And the response has not been filed by the complainant till date.</p> <p>On the last date it has been brought to the notice to the Authority that the matter for impleadment of M/s Prime IT Solutions Private Limited is pending before the Hon'ble High Court of Punjab and Haryana, at Chandigarh, in RERA Appeal no. 113/2023, (CR no. 4684 of 2020), wherein the Hon'ble High Court vide its order dated 02.11.2023 has directed not to pass any final order in the present matter. Since the above case is also identical w.r.t. impleadment of M/s Prime IT Solutions Private Limited and hence the same may be heard after the matter is decided in the Hon'ble High Court or any further directions are received in this regard.</p>
