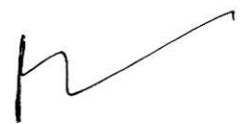

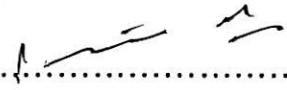
settle the matters by the next date of hearing, else the matters shall be argued.
