ORDER: (DR. GEETA RATHEE SINGH-MEMBER)

1. During the last hearing held on 05.07.2023, it was informed by the Ld.
Counsel for respondent that he has been informed by the



respondent/promoter that vide order dated 16.06.2023 passed by the Hon'ble National Company Law Tribunal, Chandigarh in CP (IB) No. 132/CIID/IRY/2022 in the matter of Capriso Finance Ltd and another versus Trishul Dream Homes Ltd., moratorium has been imposed under section 14 of Insolvency and Bankruptcy Code, 2016. Ld. Counsel for respondent informed that moratorium is still continuing. Keeping in view the continuation of NCLT proceedings and moratorium, the Authority will hear the matter after completion of NCLT proceedings. However, the respondent counsel is directed to place on record a copy of information memorandum prepared by IRP and copies of orders passed by Hon'ble NCLT/NCLAT, before the next date of hearing.
