2. Today, Id. counsel for complainant apprised the Authority that applications seeking amendment of relief sought particularly para (b)



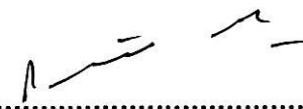
have been filed in registry on 03.09.2024 in captioned complaints with advance copies supplied to respondent.
