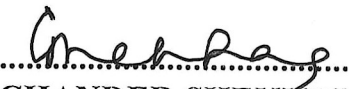

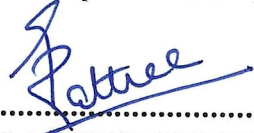
ORDER (NADIM AKHTAR-MEMBER)
