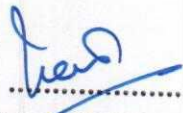

ORDER (DR. GEETA RATHEE SINGH - MEMBER)

1. Sh. Karaninder, proxy counsel for the complainants has apprised the Authority that order dated 16.11.2022 passed by Hon'ble National Company Law Tribunal, New Delhi has been ordered to be stayed by Hon'ble National Company Law Appellate Tribunal. Further he stated that accounts of the complainant-promoter are yet not released by the Insolvency Resolution Professional. Furthermore, he sought adjournment in captioned complaint on the ground that arguing counsel Sh. Ajay Ghangas is not available to argue the matters on its merit.
2. On the other hand, none appeared on behalf of respondents except in complaint no. 395 of 2020. Sh. Jagdish Monga, has appeared on behalf of respondent and has filed an application-reply along with authorization letter.
