ORDER(DR. GEETA RATHEE SINGH- MEMBER)

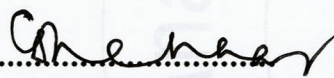

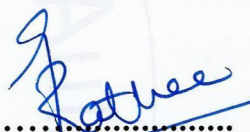
