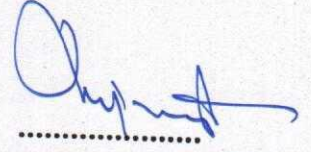
ORDER **(DILBAG SINGH SIHAG - MEMBER)**
