1. Sh. Learned counsel for respondent made a statement that all the projects of M/s Ansal Properties & Infrastructure Ltd. are covered for moratorium under section 14 of Insolvency and Bankruptcy Code by the Hon'ble National Company Law Tribunal, New Delhi.
