1. This appeal filed by the Revenue is emanating out of the order of Commissioner of Income Tax (A) – 7, Pune dated 16.05.2019 for the assessment year 2009-10.
2. On the date of hearing, Ld. D.R. submitted that the tax effect in the present appeal is below the monetary limit as prescribed by the recent CBDT Circular No.17/2019 dt.08.08.2019 and therefore Revenue would like to withdraw the appeal filed by Revenue. He placed on record

the copy of the letter No.PN/Pr.CIT-6/Judl/Withdrawal/ITAT/2019-20/1962 dt.25.10.2019 to that effect. He therefore submitted that the appeal be decided accordingly.
