These appeals by the assessee are directed against the orders of Commissioner of Income Tax (Appeals)-2, Pune for the assessment years 2009-10 and 2010-11 confirming the levy of penalty u/s. 271(1)(c) of the Income Tax Act, 1961 (hereinafter referred to as “the Act”). Both the impugned orders are dated 30-09-2015.

2. The assessee has filed an application dated 17-01-2017 to withdraw the appeals and to avail the remedy under Direct Tax Dispute Resolution Scheme 2016.
