The appeal filed by the assessee is directed against the order of the Id. Commissioner of Income Tax (Appeals) - 4, Pune ('CIT(A)' for short) dated 24.05.2017 for the Assessment Year 2014-15.

2. Before us, the appellant filed a letter dt.22.01.2021 seeking permission to withdraw the appeal on the ground that the issue involved in these appeal stands settled under the Vivad Se Vishwas Scheme, 2020. The appellant also filed copy of Form No.3 issued by Principal Commissioner of Income Tax, Pune – 3.
