All these writ petitioners raise a common grievance having regard to a communication dated 28.07.2023 issued by the Joint Registrar of Co-operative Societies, Mysore, directing the Deputy Registrar of Co-operative Societies of Mysore, Chamarajanagar, Mandya, Hassan, Chikkamagaluru, Kodagu, Dakshina Kannada and Udupi Districts and also the Assistant Registrar of Co-operative



Societies, Mysore, Hunsur, Chamarajanagara, Mandya, Pandavapura, Hassan, Sakaleshapura, Chikkamagaluru, Tarikere, Madikeri, Mangaluru, Puttur and Kundapura Sub-Divisions, to ensure registration and establishment of a Primary Agricultural Credit Co-operative Society within the jurisdiction of every Gram Panchayat in the District. For that purpose, a time schedule was also mentioned in the communication. Subsequently, another communication was also issued on 01.08.2023 directing the Chief Executive Officer of the Primary Agricultural Credit Co-operative Societies, Kundapura, Udupi and Karkala Taluks to implement the directions issued on 28.07.2023.

2. Learned Additional Government Advocate, however, submits that there were several oppositions to the said action sought to be taken by the Government and as a consequence, the Government ensured that the directions are not implemented. However, the learned Additional Government Advocate submits that if the Government intends to implement such a rule, necessary action will be taken in accordance with law. At any rate,



since the timeline fixed in the impugned communication dated 28.07.2023 could not be implemented, the prayers made in the writ petitions do not survive for consideration.

3. Learned Counsel for the petitioners however submit that liberty should be given to the petitioners to come before this Court, if such action is taken by the Government.

4. Accordingly, the writ petitions stand disposed of, in view of the subsequent development as narrated hereinabove. Needless to observe that if any of the Co-operative Societies or members of the Co-operative Societies are opposed to such a move at the hands of the Government, they are free to approach this Court, if the action of the Government is not in accordance with law. Ordered accordingly.

Pending I.As., if any, stand disposed of.
