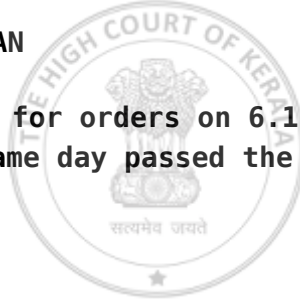

Respondent seeks time for two weeks. The petitioner has only produced the impugned order. The impugned order is directed against an application, preferred by the petitioner, to raise an additional issue. The petitioner will produce the interlocutory application in which the impugned order was passed. The petitioner shall also produce a copy of the plaint and written statement, copy of the plaint, written statement, I.A. leading to the impugned order and counter affidavit, if any, to that I.A.

2. This Court notice that the impugned order was passed on 27.02.2023 and the CRP was filed on 17.03.2023 and the same was pending before this Court till now.

3. It is submitted by the learned counsel for the petitioner that, the suit is posted for trial on 08.11.2023. In the circumstances, there will be a stay of the trial of the suit.
