Writ petition (civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to i) issue a writ of certiorari or any other appropriate writ, order or direction to quash ext.p2 issued by the 2nd respondent to the extent of insisting production of development permit, after calling for the records leading to its issuance; ii) issue a writ of mandamus or any other appropriate writ, order or direction to the respondents to consider the application submitted by the petitioners for building permit and issue building permit to them for constructing building in 2.02 ares of property comprised in survey no.695/1 of nenmanikkara village in mukundapuram taluk forthwith, without insisting development permit; iii) issue such other reliefs as this hon'ble court may deem fit and proper in the facts and circumstances of the case; & iv) petitioners also pray that this hon'ble court may be pleased to dispense with production of translation of the documents produced in vernacular language.
