5. Counsel for the Applicant has pointed out that the NCT of Delhi is already a respondent in these proceedings. Hence, he is directed to inform the Chief Secretary, NCT Delhi about the next date of hearing.

6. Learned counsel for MCD is at liberty to place on record the details of the proceedings which is pending before the Delhi High Court.
