ORDER

1. The Tribunal by the order dated 19.03.2025 had directed the respondents to file additional reply disclosing monthly and yearly use of

quantity of water for irrigation of the Cricket ground, proportion of STP treated and fresh water supplied from municipality/ULB or any other source. The Tribunal by order dated 17.07.2025 had directed the respondents to furnish advance copy of such reply to the Counsel for the Central Ground Water Authority (CGWA) who was further directed to compile the information disclosed in those replies and submit the information in tabulated form.

2. Learned Counsel appearing for the CGWA submits that replies only on behalf of the Tamil Nadu Cricket Association, Punjab Cricket Association, Vidarbha Cricket Association, Cricket Association of Bengal and Mumbai Cricket Association have been received.

3. Learned Senior Counsel appearing for Haryana State Cricket Association also submits that he has e-mailed a copy of the reply to the Counsel for CGWA. The replies on behalf of the other Cricket Associations have not been received by the Counsel for the CGWA till now, hence, they are directed to file the same and furnish a copy thereof to Counsel for the CGWA positively within four weeks.
