**ORDER**

1. It has been pointed out that the main issue involved in all these original applications is in respect of defining the flood plain zones of River Ganga and its tributaries and action against the unauthorized construction within the prohibited limits in the Sate of UP.

2. Learned Counsel appearing for the State has fairly submitted that he will prepare a compilation of all the relevant orders of the High Court especially those wherein the limits restricting the constructions from the river bank of Ganga have been provided and specified and will also prepare a chart containing the details of the districts and cities involved in each of the connected OA and the issues raised therein. He is also directed to include the rejuvenation order of 2016 in his compilation.

3. Counsels for all the parties are directed to supply a copy of the pleadings in their respective OA to Counsel for the State to enable him to prepare a proper compilation and assist the Tribunal.

4. In OA No. 517/2023, the wife of the Petitioner No. 7, Subhashish Chatterjee has appeared and has informed that the said Petitioner has died in 2017. She has prayed for some time to file a proper application for bringing her on record as legal representative of the deceased Petitioner No. 7. Let the same be done before the next date of hearing.

5. As the matters are pending since long, therefore, in the meanwhile, if any of the parties has died or there is change of status of parties, it will be open to the concerned party/Counsel for the party to file a proper application before the next date of hearing.
