ORDER

1. Communication dated 06.07.2024 has been issued to the CPCB, Noida Authority and Public Works Department to nominate the officers in the Joint Committee. In this background, prayer has been made for extension of time to file the report by the joint Committee. The said prayer is duly allowed.

3. I.A. No. 273/2024 has been filed by the applicant for withdrawal of the OA. Learned Counsel for the respondents are granted four week's time to file response to the I.A.

4. The Applicant submits that the copy of IA has been supplied to the respondents but the stand of the respondents is that the same has not been received. Office is directed to upload the I.A. on the website and it will be open to the respondents to download it and file response to the IA within four weeks.
