ORDER

1. Tribunal by order dated 21.05.2024 had appointed a four members joint committee with a direction to the committee to visit the site, ascertain the nature and extent of construction of each of the applicant and ascertain other facts stated in paragraph 6 of the said order.

2. Learned Counsel for State of UP submits that since no nomination was made by Chief Engineer, CPWD, therefore, exercise which was to be conducted by joint committee has been delayed. He has submitted that till now Chief Engineer, CPWD has not nominated anyone. Therefore, remaining members of the joint committee have started the exercise and

they have done the inspection of 37 constructions out of 50 existing on the spot. He has also submitted that though an interim report in this regard has been filed by the committee but it was filed belatedly, therefore, it has not come on record. He sought three days to complete the entire exercise and file a full comprehensive report. The prayer is allowed.

3. Supplementary affidavit has been filed by the petitioners on 17.11.2024.

4. Learned Counsel for respondents are granted 10 days' time to file a response to the supplementary affidavit.

5. Learned Counsel for respondent no.6 submits that joint reply to IA No.273/2024 and supplementary affidavit of the applicant considered today will be filed by respondent no. 6 within 10 days.
