Application is registered based on a Letter Petition received by Post.

ORDER

1. M/s. Rajveer Plastic, F-28, Block G, Sanjay Colony, Sector -22, Faridabad, Haryana has sent the present letter petition, which is registered and treated as original application, is that factory number 2155 situated in I Block of Narela Industrial area is illegally manufacturing prohibited plastic carry bags in violation of environmental norms. The owner of the factory has staked bags containing plastic granules in the front and prohibited plastic manufacture in the back portion.

2. This Tribunal is empowered to *suo moto* take cognizance of the cases involving questions relating to environment arising out of the implementation of enactments specified in First Schedule of the National Green Tribunal Act, 2010 as held by Hon'ble Supreme Court in **Municipal Corporation of Greater Mumbai V/s. Ankita Sinha and others 2021 SSC Online SC 897.**

This Tribunal can also take cognizance of such cases on the basis of letter petitions in accordance with settled principles of law governing Public Interest Litigation.

3. *Prima facie*, the allegations made in the application raise questions relating to environment arising out of the implementation of the enactments specified in Schedule I to the National Green Tribunal Act, 2010. In view of the allegations made in the application, we consider it appropriate that a Joint Committee be constituted to verify the factual position. Accordingly, we constitute a Joint Committee comprising of representative of DPCC and Deputy Commissioner (North West), Delhi and direct the same to meet within two weeks, undertake visits to the site, look into the grievances of the applicant, associate the applicant and representative of the concerned project proponent, verify the factual position and submit its report within one month by e-mail at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR Supported PDF and not in the form of Image PDF. The DPCC will be the nodal agency for coordination and compliance.

4. In case the Joint Committee observes any violation of consent conditions/environmental norms then it shall forward a copy of its report to

(i) the Project Proponent to enable him to comply with the recommendations in its report or file objections against the observations/recommendations in the report of the Joint Committee and file his response before this Tribunal as desired within one month from the date of receipt of a copy of the report of the Joint Committee; and

(ii) DPCC and Deputy Commissioner (North West), Delhi to enable them to take appropriate remedial action by giving notice to/hearing the project proponent and following due process of law in accordance with Statutory provisions mandating them to take remedial action for prevention, control and abatement of environmental pollution/degradation and protection and improvement of environment and submit their action taken report within one month from the date of receipt of a copy of the report of the Joint Committee.
