**ORDER**

1. Mr. Saunak Sengupta, learned Counsel is present (in Virtual Mode) on behalf of the Appellants.
2. Additional affidavit dated 28.08.2023 has been filed on behalf of the Respondent Nos.1 to 3, Central Ground Water Board; the same is taken on record.
3. The matter was heard at great length.
4. From the documents on record, we find that the figure of 1.53 cum/day as mentioned in the Inspection Report is the quantum of dewatering withdrawn by the Appellants, which has not been explained either by the Appellants or by the Central Ground Water Board (CGWB). It is on the basis of this figure that Environmental Compensation and Penalty is said to have been computed. The Inspection Report at page No.184 of the paper book mentions "quantum of dewatering withdrawn by the firm (check Log Book)" to be 1.53 cum/day. This Log Book is not before us.

5. Mr. Ashok Prasad, learned Counsel, appearing on behalf of Central Ground Water Board drew our attention to annexure-3 (page no.182 and 182A of the paper book) which is a record of pumping data provided by the Appellants and submitted that computation of 1.53 cum/day has been arrived at on the basis of this letter. We find that this letter does not mention the figure 1.53 cum/day. The figure of 1.53 cum/day which is the basis of the impugned order passed by the Respondents remains unexplained. The basis of mathematical computation of environmental compensation has not been explained by the Respondents.
6. We, therefore, direct that an affidavit be filed by Mr. A. K. Sinha, Scientist-B who has signed the Inspection Report dated 01.09.2021 with supportive documents such as his calculation sheet / Log Book or any other methodology by which this figure of 1.53 cum/day has been arrived at by the Respondents for the purpose of computation of Environmental Compensation. Mr. A. K. Sinha, Scientist-B shall also be present in Court on the next date of listing to assist the Court.
7. Since there are nine Appeals in which similar questions have arisen, Sri A. K. Sinha, Scientist-B shall file affidavit in all the connected Appeals.
8. The affidavit should be filed within 10 days and copy of the same shall be served upon the Counsel for the Appellants at least three days before the next date of hearing.
