ORDER

1. By the previous order of this Tribunal dated 13.01.2026, the Registry was directed to implead the West Bengal Mineral Development and Trading Corporation Limited (WBMDTCL) as Respondent no.20 but the same has not been impleaded in the memo of parties. Therefore, we direct that the same be impleaded now positively by the Registry and thereafter, the Registry shall issue notice to the Respondent no.20, returnable within four weeks. Steps shall be taken in this regard by the Applicant within a week.

2. The Applicant was also directed to implead the legal heirs of the deceased Applicant no.2 regarding which it is informed by the learned Counsel for the Applicant that they have moved I.A. No.22/2026/EZ but it is not restored by the Registry on record. Therefore, we cannot take up hearing of the said application as well. We direct the Registry to restore the same on the next date and objections if any against the said application will be filed by all the parties within two weeks.

3. Put up this matter for next consideration on 03.07.2026.
