ORDER

(I.A. No. 51/2024)

1. Learned counsel for the Respondent no. 5 Mr. Rohit Sharma has moved this application for modification of the order dated 21.03.2024 to the extent that in the order dated 21.03.2024 in para 10 the enforcement of the guidelines is entrusted to “Collector, Bharatpur, Rajasthan and SEIAA, Rajasthan” and his submission is that SEIAA, Rajasthan is not executing agency, thus, the name of SEIAA, Rajasthan be deleted. Accordingly, in para 10 of the order dated 21.03.2024, the name of SEIAA, Rajasthan, is deleted. **I.A. No. 51/2024** stands **disposed of** accordingly.

2. Applicant has moved this application to implead Central Empowered Committee (CEC) as respondent on the ground that Hon'ble Supreme

Court of India vide order dated 08.12.2021 titled M.C. Mehta Vs. Union of India & Ors. in Writ Petition (Civil) No. 13381/1984 has directed some work to CEC and on this ground the learned counsel for the applicant has argued that CEC may also be impleaded as a necessary party. CEC is the body constituted by the Hon'ble Supreme Court of India thus it is neither necessary nor proper party. **I.A. No. 29/2024** stands **disposed of** accordingly.

3. Today, during the course of hearing learned counsel for the State of Rajasthan has filed the action taken report/report submitted by the Collector, Jila Magistrate and the Forest Department.
