ORDER

1. Learned counsel for the parties have submitted that aggrieved by the order impugned dated 31.07.2023 passed in original application no. 102/2022 the aggrieved approached the Hon'ble Supreme Court of India by filing Civil Appeal (diary no. 39904/2023) and the appeal was disposed of as withdrawn vide order dated 17.10.2023.

2. Later on Miscellaneous Applications have been moved to modify the order or recall the order. Learned counsel for the State PCB has submitted that the objections/reply has been filed.

4. Learned counsel Mr. Shantanoo Saxena has submitted that the M.A. Nos. 05/2023 and 06/2023 involves a separate issue with regard to limit of eco-sensitive zone.
5. Vide order dated 06.09.2023 question of maintainability of the application was raised. Since today is the last working day before the winter vacation thus learned counsel for the parties are in agreement that the pleadings be exchanged and matter may be fixed in the January, 2024 for hearing of the applications.
