ORDER

1. Shri Dileep Kumar Yadav, District Collector, Mandsaur (State of Madhya Pradesh) is personally present and stated frankly that the correct map of 'Teliya Talab' as per the directions of Supreme Court could not have been prepared by the Committee and he seeks 3 weeks' time to prepare the map and submit a complete report before Tribunal along with the material on the basis whereon map shall be prepared.

2. Let the said report be submitted by 14.09.2023.

3. List this case on 14.09.2023.

I.A.No.46/2023:

4. This is an application for impleadment of Suresh Singh Shekhawat who claims that he is likely to be affected if an order is passed in the present matter relating to 'Teliya Talab' since his property is likely to be adversely affected if map given by authority is given effect. None has raised any objection for his impleadment.
