ORDER

Applicant is directed to take necessary steps within a week. Pleadings may be exchanged.
5. List it on **26th July, 2024**. In the meantime direction containing para 6 and 7 of the order dated 11.03.2024 be complied by the authorities concerned. Rejoinder by the applicant be taken on record.
