ORDER

1. Ms. Meenakshi Patidar, Learned Counsel mentioned the I.A. No. 145/2023 moved in O.A. No. 77/2020 which is reported to be listed on 12.03.2024 which was lastly listed on 06.12.2023. The contention of the Learned Counsel is that application was moved before the Hon'ble High Court by moving the Writ Petition No. 29675/2023 which was finally disposed of by Hon'ble High Court vide order dated 05.12.2023 with the direction to the petitioner to approach the National Green Tribunal within a time limit.
2. I.A No. 145/2023- An application for urgent hearing and for interim order has been moved. Issue notice to the opposite parties. Put up with record.

3. I.A. No. 146/2023 – An application has been moved to intervene in this Original Application. Copy of the application with relevant document be provided to the applicant for response/objection if any.
4. Since the working of the Tribunal remains only for two days and notices are required to be issued to the opposite parties in addition to calling a report from the state authorities, for which the Learned Counsel Mr. Prashant M. Harne is present and sought a short time to call a report from the authorities concerned. The Applicant in I.A. is directed to provide the copy of the I.A. to the Learned Counsel for the State and also serve the notice with the documents to the opposite parties, applicant as well as Respondent and the State Authorities as early as possible. In the meantime, urgency has been shown by the Learned Counsel Ms. Meenakshi Patidar. A High Level Committee consisting Principal Secretaries, Revenue Officers and District Collector has already been constituted and the committee is also examining the records and alternate remedy is available to the Applicant to raise the grievances before the aforesaid High Level Committee and Committee may decide according to law and proceed according to rules.
5. List these I.As i.e. 145/2023 & 146/2023 on **12th January, 2024** subject to condition that applicant must serve the copy of the application and notice to the opposite parties.
