ORDER

1. We find that a large number of parties have moved applications for the deletion. But we deem it appropriate that instead of dealing with these applications in piecemeal, these applications will be disposed of only after hearing the arguments of the parties on merit. As the parties are saying that there is no allegation on merits against them. But even then, we are not going to take up any of the applications for deletion at this stage.
2. Learned counsel for the respondent no. 17 moved an application I.A. 141/2026 seeking modification of order passed by this Tribunal on 06.02.2025. We direct that objection against the same will be filed by all the parties within one week.
3. Another two I.As, i.e. I.A. No. 140/2026 is moved by respondent no. 20 and I.A. 137/2026 have been moved by respondent no. 18 seeking the same relief of modification in the order dated 06.02.2026.
4. We direct the learned counsel for the applicant as well as other parties learned counsel to file reply of the above I.As, if any, within one week.
5. Put up this matter for disposal of these three I.As on 24th March 2026.
