ORDER

1. From the side of the applicant, the applicant-in-person has appeared and admitted candidly that he has not served copy of the Original Application on the learned counsel for respondent No.2 – GPCB, who is present today through videoconferencing.

We allow this I.A. and direct the applicant to provide copy of the Original Application to learned counsel Mr. Arun Siwach today itself through e-mail and the reply-affidavit shall be filed by respondent No.1 within two weeks.

5. Put up this matter for admission on 27.07.2023.
