**ORDER**

1. From the side of the appellant, Mrs. Judith Almeda, applicant in-person has appeared, who submits that reply affidavit filed by respondent No.3/Project Proponent has been received by her two days ago i.e. on 16.07.2023, which needs to be responded by filing a rejoinder, for which she may be allowed two weeks' time, the same is allowed.

It also transpired that the objection dated 30.05.2023, which has been filed by the appellant against the inspection report dated 06.04.2023, has not been served upon the learned Counsel for the respondent No.3/Project Proponent, which is being controverted by the appellant and submits that the same has been sent through e-mail address, which has been mentioned in the memo of appeal of respondent No.3. But the learned Counsel for the respondent No.3 submits that the

same has not been delivered. Therefore, in the interest of justice, we direct the appellant to send a copy of the same upon the learned Counsel for the respondent No. 3 today itself and reply to that, if any, may be filed by the learned Counsel for the respondent No.3 within a week.

3. From the side of respondent No.1/GCZMA and for respondent No. 2/State of Goa through Chief Secretary, learned Counsel Ms. Manasi Joshi has appeared, who seeks one week's time to file reply affidavit to the objection of the appellant against the inspection report, if need is felt, the said time period is allowed.
