ORDER

1. Learned Counsel appearing for the State of Andhra Pradesh submits that there has been a change of Counsel by the State and she has been recently engaged and accordingly has sought short adjournment.
2. It has been pointed out that Respondent No. 7-Karnataka State Coastal Zone Management Authority and Respondent No. 12- West Bengal Coastal Zone Management Authority (in OA No. 106/2022(WZ)) have not filed their replies in any of these matters.
3. It will be open to these States to file their reply within four weeks.
4. Learned Counsel appearing for the State of Goa and Goa CZMA has submitted that no separate reply on their behalf is required and the State of Goa and Goa CZMA are adopting the reply filed by the MoEF&CC.
5. It has also been pointed out that the reply on behalf of the Respondent No. 16-Andaman & Nicobar Coastal Zone Management Authority and Respondent No. 17- Ministry of Earth Science have not

been filed till now. It will be open to these respondents also to file their reply within four weeks.
