ORDER

1. From the side of applicants, learned counsel Mr. Udaynath Bicholkar has appeared, who has filed withdrawal application dated 13.02.2024, wherein following is stated:-

“That the Hon'ble High Court of Bombay at Goa in P.I.L.Writ Petition No. 5 of 2024 had initially passed interim Order on 16/01/2024, that there should not further loading or unloading of ore and even unloaded ore should not be transported from where it is already stacked and thereafter finally on 05/02/2024 disposed the said P.I.L.Writ Petition No. 5 of 2024 and the said order records that no further unloading/loading shall take place till a permit is obtained, after due application, from the Chief Wild Life Warden of the State under the provisions of Wild Life Protection Act, 1972, hereto annexed the copy of Order dated 05/02/2024 passed by Hon'ble High Court of Bombay at Goa in P.I.L.Writ Petition No. 5 of 2024.”

2. A copy of the Judgment passed in Writ Petition No.05/2024 by the Hon'ble High Court of Bombay is also annexed with the said application.

3. Based on the above, it is argued that the relief, which was sought in the present application to get the declaration that no activities of

unloading/dumping of Ore/Cargo be permitted in the property bearing Survey Nos.104/1, 104/2 & 106/1 of Village Kalay, stands complied in the light of the Judgment passed by the Hon'ble High Court of Bombay. Therefore, applicants do not want to press this application.

4. From the side of respondent No.2-GSPCB, learned counsel Mr. Pavithran A.V. has appeared, who submits that he has no objection, if the said application is allowed to be withdrawn at the stage of admission.

5. Therefore, we allow the prayer made by the applicants and dismiss this application as withdrawn.
