ORDER

1. By this Application, the Applicant seeks Original Application No. 50/2020 to be heard on urgent basis. He has drawn our attention to the averments made in paragraph 7 (g) of the Original Application, wherein he has stated that the Project Proponent in this case had constructed one bungalow, compound wall in prohibited area i.e. blue line of river Indrayani and the said construction has been made in Survey No. 90(P), near River Residency, Village: Chikhali, Taluka: Haveli, District: Pune.

2. The Applicant has drawn our attention to the report of Joint Committee in order to substantiate his claim wherein Land Survey No. 90 is shown within blue line of river Indrayani and towards reverse side of it, there is dumping shown by green color. The said map filed today is taken

on record and marked as “X” for identification purpose. He has further drawn our attention to the report of the Joint Committee which too has found that the filling and the construction has been done in blue line of river Indrayani, which should immediately be removed.

3. It is argued by the Applicant that further construction is going on, being carried out by the Project Proponent which needs to be stopped immediately and that is the reason why he wants this matter to be heard on urgent basis.

4. Since this matter is adjourned by us to be taken up on 02.03.2023 and we are in the month of January, 2023 we deem it appropriate to take up this matter for hearing and hence, we direct the Registry to place this matter for hearing on Original Application on 02.02.2023.

5. The Applicant is directed to inform the other parties in writing about the fact that the matter would be taken up on 02.02.2023.
