ORDER

1. The same is taken on record. A copy of the same is said to have been served upon learned counsel for the applicants. Therefore, we direct that rejoinder affidavit against the same, if any, may be filed within four weeks, as prayed.
3. Learned senior counsel for Respondent No.4- Project Proponent has also moved I.A. No.201 of 2026 (WZ), praying therein for permission to be allowed to take on record the additional documents/facts.
4. In the above I.A., the main emphasis laid by learned senior counsel for Respondent No.4 is that since the new EC dated 26.11.2025 has been allowed in favour of the Answering Respondent for setting up of a new timeline for providing garages etc., the present execution application has become infructuous.

5. A copy of the above I.A. is said to have been served upon learned counsel for the applicants. Therefore, we direct that objection against the same, if any, may be filed within four weeks, as prayed.
