ORDER

1. We have heard the argument of learned Senior Counsel Shri Pinaki Misra representing respondent No.4- Project Proponent, who prays for additional time to be allowed to submit timeline and detailed Action Plan, which was ordered to be submitted by our previous order dated 26.09.2024. He submits that in this matter, there are 5 to 6 agencies involved, which are Government bodies, which are busy in election duty. Therefore, it could not be feasible to meet the deadline of filing the same. As prayed, we allow four weeks' additional time to the respondent No.4 for the same.

2. From the side of execution applicants, learned counsel Mr. Aditya Pratap has appeared before us, who has vehemently opposed the adjournment of this matter and has drawn our attention to the Undertaking submitted by the respondent No.4- M/s. Skylark Buildcon Pvt. Ltd., which is annexed at page nos.126 to 127 of the paper book, wherein it is undertaken to provide car parking by March 2025 and it is apprehended by him that in case any further time is extended, that undertaking would be breached.

3. We would pass order with regard to as to what is to be done if the breach takes place. But as of now, we have no option but to grant four weeks' additional time by way of last opportunity to the respondent No.4.

4. We direct the Registry to list this matter for final hearing on 13.01.2025.
