ORDER

1. On perusal of the memo of this Execution Application, we find that the execution applicant has not impleaded all the respondents of Original Application No.75/2021 as respondents in this Execution Application. We direct the applicant to submit amended memo of Execution Application today only impleading all the respondents of O.A. No.75/2021 as respondents in this Execution Application.

2. By this application, the applicant seeks execution of the order dated 22.02.2023 passed by this Tribunal in Original Application No.75 of 2021, whereby it was directed that respondent No.1 – Gram Panchayat, Maan shall deposit an amount of Rs.34,00,000/- (Rupees Thirty Four Lakhs) towards Environmental Damage Compensation with respondent No.6 – MPCB, which has not been complied with so far despite the time

within which the said order was directed to be complied with, having elapsed.

3. Hence, we admit this Execution Application and direct the Registry to issue notices presently to respondent Nos.1 – Gram Panchayat, Maan and respondent No.6 – MPCB. Since learned counsel Ms. Pooja Natu, holding brief of learned counsel Ms. Manasi Joshi has appeared for respondent No.6, service of notice to this respondent is waived by her. Notice to respondent No.1 be made returnable within four weeks.

4. Learned counsel for respondent No.6 seeks four weeks' time to file the reply. The same is allowed.

5. The applicant is directed to provide copies of the Execution Application and annexures thereto to respondent Nos.1 and 6 within a week.

6. The applicant is also directed to take necessary steps for service upon respondent No.1 by both ways and also through available e-mail.

7. Put up this matter for next consideration on 22.11.2023.
