**ORDER**

1. From the side of the execution applicant, learned counsel Mr. Saurabh Kulkarni has appeared and submits that the service of notice has been effected upon respondent No.1 – Gram Panchayat, Maan and has annexed tracking report in order to establish that the notice has been delivered to respondent No.1 although he has not annexed any affidavit stating that respondent No.1 has been served. We do not find from the tracking report whether it relates to respondent No.1 only. Therefore, learned counsel for the applicant submits that he would be filing an affidavit in that regard. The same is directed to be filed within a week.

2. None has appeared from the side of respondent No.1 – Gram Panchayat, Maan.

3. In compliance of our previous order dated 11.10.2023, respondent No. 6 – MPCB has filed the reply-affidavit dated 21.11.2023 wherein it is stated that calculation of the Environmental Damage Compensation (EDC) has been revised to the tune of Rs. 43,00,000/- for the period from 01.04.2020 to 31.10.2023 in accordance with the norms laid down by this Tribunal in O.A. No.606/2018 and a letter dated 17.11.2023 has been sent to Gram Panchayat, Maan, directing it to deposit the said amount within fifteen days, which would lapse on 02.12.2023.
4. We direct respondent No.6 – MPCB to serve a copy of the aforesaid affidavit dated 21.11.2023 upon respondent No.1 – Gram Panchayat, Maan and respondent No.1 may file objections, if any against the same within a week.
5. Put up this matter for next consideration on 07.02.2024.
