ORDER

1. This interlocutory application [I.A. No.08 of 2023 (SZ)] is filed for advancing the date of hearing from 28.02.2023 to a nearer date.
2. In our last order, we had mentioned that the action plan was silent about the timeline within which the Upgradation of the Sewage Treatment Plant and increase of the quality of the treated water and also shifting of the UGD Network in Nagarakere Lake will be completed.
3. On 11.01.2023, the Deputy Commissioner – Bengaluru Rural District filed a report wherein, it is stated that the work for shifting of UGD sewer network from Nagarakere Lake and the action plan regarding the same was approved by the Government of Karnataka on 16.05.2022 under the '*Amrutha Nagarothana (Municipality) Scheme, Phase – 4*'. As per the same, it is stated that finalizing the bidder including the tender process would be done on or before 20.02.2023 followed by a letter of intent and issuance of a work order to the successful bidder within 10 days. Thereafter, within 120 days (i.e. on or before 30.06.2023) the work would have commenced and completed.
4. So, we direct the authorities to strictly comply with the timeline mentioned in the report and inform the progress of the same to this Tribunal on the next date of hearing i.e. 17.02.2023.

5. Accordingly, the I.A. No.08 of 2023 (SZ) is closed and the date of hearing is advanced to 17.02.2023 from 28.02.2023.
