COMMON ORDER

1. As the issues raised in the above appeals [Appeal Nos.02 to 12 of 2024 (SZ)] are similar in nature, all these matters are taken up together for consideration.
2. The above appeals are directed against the impugned order passed under Section 5 of the Environment (Protection) Act, 1986 vide Order No. KSPCB/977/2023-EE-1 dated 28.11.2023 by the Kerala State Pollution Control Board levying environmental compensation of Rs.5,41,417/- (Rupees Five Lakhs Forty One Thousand Four Hundred and Seventeen only).
3. Let notice be issued to the respondents through the Tribunal as well as privately.
4. The learned counsel Mrs. V.K. Rema Smrithi accepts notice on behalf of the Kerala State Pollution Control Board/ Respondents No.1 to 3.
5. Heard the learned counsels.
6. **There will be an order of interim stay on condition that the appellant in Appeal Nos.02 to 12 of 2024 (SZ) respectively, furnishes the Bank Guarantee of Rs.1,50,000/- (Rupees One Lakh and Fifty Thousand only) in favour of the Kerala SPCB's Environmental Protection Fund (as mentioned in the impugned order) within a period of 4 (Four) weeks, failing which, the stay granted will be automatically vacated without further reference to this Tribunal.**
