ORDER

1. In our earlier order, after perusing the reports of the Tamil Nadu Pollution Control Board, SEIAA - Tamil Nadu, and also the District Collector, we directed the Tamil Nadu Pollution Control Board and the SEIAA - Tamil Nadu to once again inspect the application mentioned property for quarrying as well as crushing operations, after issuing a notice to the respective parties and the Pollution Control Board was also directed to assess the environmental compensation for the violations (if any) found.
2. Despite granting two weeks time, there is no report filed and the reason given is that both the departments are unable to coordinate with each other.
3. While so, the applicant complains again that the crushing operation is happening with the newly installed machinery, for which, even the Consent for Establishment (CFE) was not obtained. If that is so, it will be detrimental to the interest of the project proponent. However, the same will be decided only after the report of the Tamil Nadu Pollution Control Board and the SEIAA - Tamil Nadu is filed after making the inspection.
4. It is now stated that both authorities have nominated the respective officers to go and inspect and scheduled the inspection on 16.03.2023. However, notice has to be given to the applicant as well as the project proponent before they inspect the property.

5. Let a detailed report be filed by the authorities as directed before the date of next hearing.
6. Let the matter be listed on 23.03.2023.
