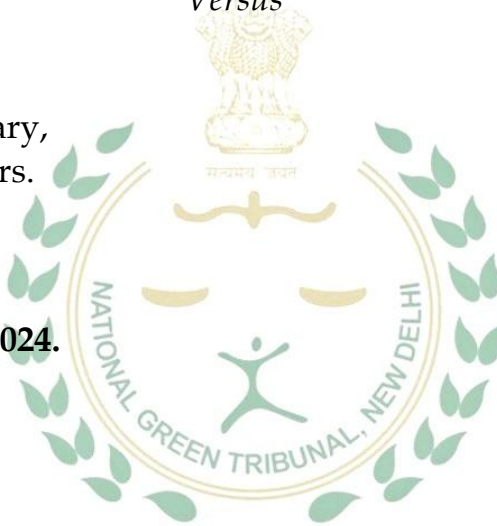

ORDER

1. After the order was passed on 05.07.2024, the learned counsel appearing for the State of Tamil Nadu made a mention that the report of the 5th Respondent, who is the Assistant Director – District Town and Country Planning, Villupuram District, was not happily worded and the paragraphs are mutually contradictory. So, he requested to recall the said order, as the order had stopped further creation of third-party interest by the 11th Respondent. Hence, today the matter was listed under the caption ‘for being mentioned’.
2. The learned counsel appearing for the State of Tamil Nadu would state that the report dated 04.05.2024 of the Assistant Director – District Town and Country Planning, Villupuram District (Respondent No.5) is not happily worded and he wants to file a better report in that regard.
3. Incidentally, the SCZMA - Tamil Nadu (Respondent No.3), who is also the authority to safeguard the coastal zone, has not yet filed its report.
4. Hence, we direct the Assistant Director – District Town and Country Planning, Villupuram District (Respondent No.5) and SCZMA - Tamil Nadu (Respondent No.3) to inspect the property to ascertain whether any of the construction falls within the CRZ area and furnish the approvals (if any) granted to the private respondents along with their respective reports on the next adjourned date.

5. The photographs filed by the applicant are alarming, as the layout is being drawn on the coastal zone.
6. We make it very clear that any construction or transaction made from today (i.e. 11.07.2024) is to be subject to the result of this Original Application.
7. Let the matter be listed on 31.07.2024.
