**ORDER**

1. The learned counsel Mr. S. Janarthanan entered appearance on behalf of Respondents No.2 & 5 in both cases.
2. On 25.05.2023, an interim order granted already was extended stating that "... Eventually, if it is found that the project proponent is proceeding with the work, the same would be viewed very seriously".
3. On the side of the respondents, notices were accepted and they were also directed to take action.
4. The Godavari River Management Board (GRMB) represented by its Member Secretary has got definite powers as defined in S.O. 2843 (E) dated 15.07.2021.

5. The learned counsel appearing for the GRMB states that the Project Proponent will be issued with a notice to stop the operation of the project immediately.
6. It has been brought to the knowledge of the GRMB as well as the MoEF&CC that this particular project is being carried on without obtaining Environmental Clearance (EC). This Tribunal has also already granted an interim order not to proceed with the work further without obtaining appropriate Environmental Clearance (EC).
7. In this regard, we direct the Member Secretary – Godavari River Management Board (GRMB) and also the Additional Chief Secretary – Irrigation & CAD Department, State of Telangana to look into the issue and take appropriate action and report the same by way of filing the report of status before the next hearing date.
8. Post the matter on 24.07.2023.
