ORDER

1. The report dated 03.08.2023 of the District Collector – Sangareddy District has already been filed.
2. The report refers to the inspection by the Mandal Surveyor, Jinnaram Mandal as per the revenue records. The officials of the Irrigation Department had fixed the FTL points as per the available map in the HMDA-Lakes public domain with Lake ID:1000-89. Upon fixing the FTL points, it is observed that the FTL points are falling in Survey No.82 of Bollaram Village, which is a private patta land.
3. The reply made by the District Collector is based on the joint inspection report on illegal construction in the tank bund of Varra Kunta of Bollaram Village. The joint inspection report also mentions that upon fixing the FTL points, it is observed that the FTL points are falling in Survey No.82 of Bollaram Village, which is a private patta land. However, the report further provides an opportunity for the villagers/local public/pattadars/land owners to raise objections under Sections 11, 13 and 54 of the Hyderabad Metropolitan Development Authority (HMDA) Act, 2008 on the FTL boundary maps before the final notification.
4. Therefore, it is open to Respondents No.10 to 12 to go before the authorities to establish their right. As the matter is now pending before this Tribunal and it requires factual verification by the

HMDA, the representation (if any) to be given by Respondents No.10 to 12 has to be considered at the earliest and file a report.

5. Post the matter on **21.10.2024**.
